# TRANSPORTATION FOR THE ELDERLY AND PERSONS WITH DISABILITIES



This is a Capital Assistance Program that provides vehicles to private non-profit organizations and public agencies under certain conditions, for the transportation of the elderly and persons with disabilities.

## NATURE OF THE PROGRAM

This program purchases vehicles and other equipment to help private non-profit organizations and public agencies under certain conditions provide for the special needs of the elderly and persons with disabilities in urbanized and non-urbanized areas where existing or proposed transportation services are not adequate. Applicant organizations must provide a matching fund percentage depending on the type of equipment that is ordered. The Federal Transit Administration will finance the remaining cost for approved projects.

Awards will be in the form of vehicles or other approved equipment. The type of vehicle awarded will meet the requirements of the Federal Transit Administration. The vehicles are purchased through competitive bid or from statewide contracts. Title to the vehicle will be with the sub-grantee organization.

## APPLICANT ELIGIBILITY

Only private non-profit organizations incorporated within the State of Oklahoma, public agencies, associations determined by the Secretary of Treasury to be an organization described by 26 U.S.C. § 501(c), and is exempt from taxation under 26 U.S.C. § 501 (a), or one determined under state law to be non-profit are eligible. Documentation certifying the status of being a non-profit organization must accompany each application.

## LEGAL AUTHORITY

Chapter 53 of Title 49 of the U.S. Code. Section 5310.

## CURRENT STATUS

Applications are accepted at any time.


