Invest Ed® STARS

(Students Tracking and Researching the Stock Market)

The STARS project is a free investment education program for Oklahoma high school students. Students research investments, assess risk, set goals, create and track online portfolios, and at the project's conclusion write a report. The required report differentiates this program from other online stock portfolio programs. STARS' goals include teaching students how to achieve financial freedom and raising securities fraud awareness. Additionally, the project sharpens critical thinking, research, computer and math skills, provides practice in setting goals, meeting deadlines, and writing reports. Prior to implementation, STARS teachers are trained either through the four-day STARS summer Teacher Institute or eight Saturday workshops offered in the fall and spring. The summer Refresher Workshop offers participating STARS teachers a two-day opportunity to increase their knowledge and share best practices. STARS aligns with the Oklahoma PASS Standards and is recognized by the Oklahoma State Department of Education as a resource for HB 1476. Visit investedok.org for details.
